SUSSEX SPANIEL CLUB OF AMERICA HEALTH DÓCUMENT

As a breed, the Sussex Spaniel is very low in numbers – only 34 puppies being born in 2018 in the United States, and 37 registered in the UK, 3 of which were imported.

The Sussex is a basically healthy breed, once the puppy passes the infant stage of about 2 weeks. Up until that time, the main problems health wise are regarding breeding and whelping, problems breeders have dealt with since the breed began.

At the present time, the following screenings are the only ones recommended by the Sussex Spaniel Club of America.

PDP1 testing:

Pyruvate dehydrogenase deficiency is a deficiency in the PDP1 Enzyme which regulates PDH. This can cause everything from profound exercise intolerance to sudden death. Dogs tested as "affected" should never be bred. Those tested as "carrier" should not be bred to each other and most breeders will not breed them at all. Those tested "clear" are safe to breed and do not carry the trait so cannot pass it on. This disease is a simple recessive trait and a DNA test is now available.

Cardiac abnormalities:

Heart problems can be inherited (genetic) or congenital (birth defects unrelated to genes.) They can be present at birth or develop as the dog ages. Auscultation should be done on a puppy at about 8 weeks of age. If a problem is detected, then advanced cardiac testing (Echocardiogram) should be done.

When considering the purchase of a Sussex Spaniel you should be sure to talk to the breeder about health screening they have done and any health issues that may have shown up over the years.

A health certificate from a licensed veterinarian should be given to every puppy buyer.

SSCA FIELD COMMITTEE REPORT

There have been no official SSCA field events in the past several years. In order to hold a profitable event for the SSCA, more members are encouraged to contact Patricia to express interest in participating with their Sussex. Once there is some momentum, plans can be explored to determine if a stand-alone event would be possible, or whether it makes more sense geographically and economically for the few Sussex that participate to run in other spaniel venues where their participation is permitted.

Given the resources involved in coordinating an event of this magnitude, and the low number of SSCA participants, success is dependent on gathering the necessary support of others in the field community outside SSCA for help in gunning and bird sourcing, among other components. It is likely the event, if it materializes at all, would probably take place in the mid-Atlantic or Pennsylvania region. This is due to a larger pool of possible spaniel entrants, and should increase opportunity for a financially successful event.

Delegate's Report 2019

June 2018 Meeting

The June AKC Delegates' Meeting was held on June 12, 2018, in Newark, New Jersey. The number of delegates in attendance was 310. Executive Vice President Doug Ljungren gave a presentation entitled State of the Sports - 2018 Initiatives. One aspect of the initiatives is to promote specialty clubs for low entry breeds, like the Sussex Spaniel. The AKC is looking to relax the requirement that members of a specialty club be located in a small geographic area, as well as lowering the number of members necessary to form the club. In 2017 AKC sports and events declined 2% overall. Next, Joe Baffuto, AKC Chief Financial Officer, gave a quarterly report on the AKC's finances and registration figures. The delegates voted on four rule and procedure changes.

The first vote involved an amendment to Chapter 6, Section 2, of the Rules Applying to Dog Shows - Premium Lists and Closing of Entries and Chapter 16, Section 1, of the Rules Applying to Dog Shows - Championships. This amendment changes the capitalization of "benched" and "unbenched" in Chapter 6, Section 2 for consistency, and moves an italicized sentence in Chapter 16, Section 1, to a non-italicized sentence as part of the rule, in Chapter 6, Section 2, which addresses premium list requirements. This amendment was proposed by the Dog Show Rules Committee and was approved by the AKC Board of Directors. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 6, Section 2 now reads:

SECTION 2. The premium list shall contain the following: a list of the officers of the show-giving club with the address of the secretary, a list of the members of the Event Committee (there must be at least five) together with the designation of "Chairman" and the Chairman's address (and "Obedience Trial Chairman" if an obedience trial is being held by a club in connection with its dog show), the names of the veterinarians (or name of local Veterinary Association) and, for an unbenched show, whether the veterinarian will be in attendance throughout the show hours or "on call," the names and addresses of the judges, together with their assignments, and the name and address of the superintendent or show secretary who has been approved by The American Kennel Club. The premium list shall also specify whether the show is benched or unbenched, and shall give the exact location of the show, the date or dates on which it is to be held, and the times of opening and closing of the show. Notification must be printed in the Premium List only if the club is not offering the three-point major to the Reserve Winners at the National Specialty.

The delegates next voted on an amendment to Chapter 7, Sections 2, of the Rules Applying to Dog Shows - Judges. This amendment proposes to change "license" to "approval" on the judge application form. This amendment was proposed by the Delegate Dog Show Rules Committee and was approved by the AKC Board of Directors. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 7, Section 2 now reads:

SECTION 2. The application for approval to judge must be made on a form which will be supplied by The American Kennel Club upon request and when received by said club will be placed before the Board of Directors of The American Kennel Club who shall determine in each instance whether an approval shall be issued.

Grand Championship points may also be awarded to Best of Breed or Best of Variety of Breed, Best of Opposite Sex to Best of Breed or Best of Variety of Breed, Select Dog and Select Bitch.

In addition, the Winners Dog and Winners Bitch together with any undefeated dogs that have competed at the show only in additional non-regular classes shall compete for Best of Breed or Best of Variety of Breed.

Winners Dog, Winners Bitch, and non-regular class winners that are not conformation Champions, are not eligible for Grand Championship points.

If the Winners Dog or Winners Bitch is awarded Best of Breed or Best of Variety of Breed, it shall be automatically awarded Best of Winners; otherwise, the Winners Dog and Winners Bitch shall be judged together for Best of Winners following the judging of Best of Breed or Best of Variety of Breed. If the Winners Dog or Winners Bitch was defeated in a nonregular class, it must compete for Best of Winners, but may not be considered for Best of Breed or Best of Opposite Sex. The dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater. In the event that Winners is awarded in only one sex, or only one Winners is present in the ring at the time of awards, there shall be no Best of Winners award.

After Best of Breed or Best of Variety of Breed and Best of Winners have been awarded, the judge shall select Best of Opposite Sex to Best of Breed or Best of Variety of Breed.

Eligible for this award are:

Dogs of opposite sex to Best of Breed or Best of Variety of Breed that have been entered for Best of Breed competition. The dog awarded Winners of the opposite sex to the Best of Breed or Best of Variety of Breed.

Any undefeated dogs of the opposite sex to Best of Breed or Best of Variety of Breed which have competed at the show only in additional non-regular classes.

A dog that has been defeated in any regular class or non-regular class for single dog entries in its breed or variety at the show is ineligible to compete for Best of Breed or Variety.

A dog that has been defeated by a dog of its own sex in any regular or non-regular class for single dog entries in its breed or variety at the show is ineligible to compete for Best of Opposite Sex to Best of Breed or Variety

After Best of Opposite Sex to Best of Breed or Best of Variety of Breed has been awarded, the judge may choose Select Dog and Select Bitch.

The third vote involved an amendment to Chapter 5, Section 2 of Rules Applying to Dog Shows: Ribbons, Prizes, and Trophies, which allows clubs the option of including the date on class placement ribbons. The amendment was proposed by the Delegate Dog Show Rules Committee and was approved by the AKC Board of Directors. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 5, Section 2 now reads:

SECTION 2. Each ribbon or rosette, except those used at sanctioned matches, shall be at least 2 inches wide, and approximately 8 inches long; and bear on its face a facsimile of

the seal of The American Kennel Club, the name of the prize, and the name of the showgiving club with numerals of year, date of show, and name of city or town where show is given. However, ribbons or rosettes used for regular and non-regular class placements are not required to bear the date of the show and location of the show on the face, at the option of the club.

The fourth vote involved an amendment to Chapter 7, Section 1 of Rules Applying to Dog Shows: Judges, which converts most of the italicized text to part of the rule while keeping one sentence regarding where eligibility is expanded in italics. The amendment was proposed by the Delegate Dog Show Rules Committee and was approved by the AKC Board of Directors. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 7, Section 1 now reads:

SECTION 1. Any reputable person who is in good standing with The American Kennel Club may apply for approval to judge any AKC recognized breed or breeds of purebred dogs, which in his or her opinion he or she is qualified by training and experience to pass upon, with the following exceptions:

Persons connected with any publication in the capacity of solicitor for kennel advertisements, persons connected with dog food, dog remedy or kennel supply companies in the capacity of solicitor or salesman, persons who buy, sell and in any way trade in or traffic in dogs as a means of livelihood in whole or in part, professional show superintendents and their employees, and persons who show dogs for others will not be approved if still engaged in such activities.

No Judge may accept an assignment nor officiate at any event where a member of his or her household is involved to the extent that there might exist an actual conflict of interest or the reasonable appearance of a conflict of interest.

Eligibility is expanded upon in the Occupational Eligibility Addendum and in the Rules, Policies and Guidelines for Conformation Dog Show Judges.

The fifth vote was on Chapter 9, Section 2 of Rules Applying to Dog Shows: Superintendents and Show Secretaries, which takes italicized Board interpretation and makes it into the rules. Additionally, it clarifies that an individual can only provide services for one All-Breed, or one Group club in a calendar year. The amendment was proposed by the Delegate Dog Show Rules Committee and was approved by the AKC Board of Directors. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 9, Section 2 now reads:

SECTION 2. Any qualified person may make application to The American Kennel Club for approval to act as Show Secretary of a dog show.

There is no limit on the number of Specialty Shows for which an individual may be approved Show Secretary. An individual will be approved as Show Secretary for the show or shows of only one group or one all-breed club in a calendar year. An individual must hold a license from The American Kennel Club as Superintendent in order to be approved as Superintendent for more than one group or one all-breed club in a calendar year. The sixth vote pertained to an amendment to Chapter 9, Section 4 of Rules Applying to Dog Shows: Superintendents and Show Secretaries, which broadens the requirements regarding which forms the Superintendents and Show Secretary must have available at events. All necessary forms are available on the AKC website, or sent to the Super or Show Secretary, prior to the event. The amendment was proposed by the Delegate Dog Show Rules Committee and was approved by the AKC Board of Directors. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 9, Section 4 now reads:

SECTION 4. As part of their duties, the Superintendents and Show Secretaries shall have on hand at every show the various official American Kennel Club forms related to that event.

The seventh vote was on Chapter 9, Section 12 of Rules Applying to Dog Shows: Superintendents and Show Secretaries, which cleans up wording to provide clarity, and adds a reference to eligibility requirements for this role. The amendment was proposed by the Delegate Dog Show Rules Committee and was approved by the AKC Board of Directors. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 9, Section 12 now reads:

SECTION 12. Any reputable person or superintending organization in good standing with The American Kennel Club may apply for a license to act as Superintendent of a dog show. This application must be made on a form which will be supplied by The American Kennel Club upon request. When the application is received, the Board of Directors shall determine whether the applicant is reasonably qualified by training and experience to act as Superintendent of a dog show and whether a license shall be issued to said applicant.

The fee for being granted a yearly license to be a Superintendent and the fee for renewal of said license each year shall be determined by the Board of Directors of The American Kennel Club. The fee for being granted a license to superintend one show and/or one field trial only shall be determined in like manner.

No yearly license will be issued to any person or superintending organization until having superintended at least three dog shows.

No annual superintendent shall be granted approval to be a judge.

A Superintendent, an individual licensed to superintend events as an employee of the Superintendent, any other employee of the Superintendent, any individual with an ownership interest in a superintending organization, or any person residing in the same household as any of the foregoing, shall not exhibit or act as agent or handler at any show held thirty days before or after a show which the Superintendent has been approved to service by The American Kennel Club.

For the purpose of this section, the employees of a Superintendent would include only those individuals who represent the Superintendent or superintending organization at dog shows.

Dogs owned wholly or in part by a Superintendent, an individual licensed to superintend events as an employee of the Superintendent, any other employee of the superintendent, any individual with an ownership interest in a superintending organization, or any person residing in the same household as any of the foregoing, shall be ineligible to be entered at any show held thirty days before or after a show which the Superintendent has been approved to manage by The American Kennel Club.

Any person acting in the capacity of Superintendent (or Show Secretary where there is no Superintendent) must abide by the eligibility requirements described in Chapter 11, Section 12 of these *Rules*.

The eighth vote was on Chapter 10, Section 8 of Rules Applying to Dog Shows: Duties and Responsibilities of Show Veterinarians, which adds a reference to the eligibility requirements for this role. The amendment was proposed by the Delegate Dog Show Rules Committee and was approved by the AKC Board of Directors. The question is on Chapter 10, Section 8 of Rules Applying to Dog Shows: Duties and Responsibilities of Show Veterinarians. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 10, Section 8 now reads:

SECTION 8. The official Veterinarian shall abide by the eligibility requirements described in Chapter 11, Section 12 of these *Rules*.

The ninth vote pertained to an amendment to Chapter 11, Section 1 of Rules Applying to Dog Shows: Dog Show Entries, Conditions of Dogs Affecting Eligibility, which brings the rules up to date with the intent and current practices. The amendment was proposed by the Delegate Dog Show Rules Committee and was approved by the AKC Board of Directors. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 11, Section 1 now reads:

SECTION 1. No dog shall be exhibited in a licensed or member dog show, unless it is either individually registered with the American Kennel Club, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration. A dog with an AKC limited Registration shall be ineligible to be exhibited in a breed competition in a licensed or member dog show.

An unregistered dog with an acceptable foreign registration that is individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration may, without special AKC approval, be exhibited in licensed or member dog shows that are held not later than 30 days after the date of the first licensed or member dog show in which the dog was exhibited, but only provided that the individual foreign registration and name of the country of birth, are shown on the entry form; and provided further that the same name (which in the case of a foreign-registered dog must be the name on the foreign registrations) is used for the dog each time.

Foreign dogs not individually registered with The American Kennel Club when first exhibited in a licensed or member dog show shall not be eligible to be exhibited in any licensed or member dog show that is held more than 30 days after the date of the first licensed or member dog show in which it was exhibited, unless the dog's individual AKC registration number is shown on the entry form, or unless the owner has received from The American Kennel Club an extension notice in writing authorizing further entries of the dog for a specified time with its individual foreign registration number. No such extension will be granted unless the owner can clearly demonstrate, in a letter addressed to the Show Records Department of The American Kennel Club requesting such extension, that the delay in registration is due to circumstances for which he is not responsible.

Such extension notice will be void upon registration of the dog or upon expiration of the period for which the extension has been granted if that occurs earlier, but upon application further extensions may be granted.

Additionally, any unregistered dog with an acceptable foreign registration must be eligible for the individual class in which it is entered as outlined in Chapter 3 of the Rules Applying to Dog Shows.

AKC Board of Directors. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 16, Section 1 now reads:

SECTION 1. Championship points will be recorded for Winners Dog and Winners Bitch, for each breed or variety listed in Chapter 3, Section 1, at licensed or member dog shows approved by The American Kennel Club, provided the certification of the Secretary as described in Chapter 6, Section 1, has been printed in the premium list for the show.

Championship points will be recorded according to the number of eligible dogs competing in the regular classes of each sex in each breed or variety, and according to the Schedule of Points established by the Board of Directors.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of both sexes that have been entered for Best of Breed or Variety competition and that have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its own sex that have been entered for Best of Breed or Variety competition and that have been defeated in competition for Best of Opposite Sex shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

The dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater. If no points are credited to the dog awarded Best of Winners, the regular class dogs of both sexes shall be counted in calculating championship points. A maximum of one championship point can be awarded when combining sexes for the Best of Winners point calculation.

Each AKC Breed Parent Specialty Club shall have one designated Parent Club National Specialty show per year. All others shall be termed a Parent Club Specialty show.

Unless the Parent Club, in its Application to the AKC to hold its National Specialty, chooses to exclude the following award: At the National Specialty the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the Reserve Winner's sex totals at least twice the number required for a five point major, in the region in which the event is held.

No major for Reserve Winners shall be given based upon an award of Best of Winners. In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld, shall not be included.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld, shall not be included.

The fourteenth vote was on an amendment to Chapter 11, Section 8-A of Rules Applying to Dog Shows: Dog Show Entries, Conditions of Dogs Affecting Eligibility, which requires permanent identification for a dog that is disqualified if it is ever to be considered for reinstatement. Additionally, a photo of the dog must be taken in the ring. The amendment was proposed by the

Delegates Dog Show Rules Committee and unanimously disapproved by the AKC Board of Directors at the May 2018 Board Meeting. The Dog Show Rules Committee demanded that this amendment go forward to the Delegate body for a vote, as per AKC Bylaws. There were not two-thirds voting in the affirmative, so the amendment failed.

The last vote of the meeting pertained to a second amendment to Chapter 11, Section 8-A of Rules Applying to Dog Shows: Dog Show Entries, Conditions of Dogs Affecting Eligibility. This amendment puts the reinstatement process into the rules and removes the possibility of a reinstatement occurring at events. AKC currently provides a list of dogs that have been disqualified. The amendment was proposed by the Delegate Dog Show Rules Committee and unanimously disapproved by the AKC Board at its meeting in May of 2018. The Dog Show Rules Committee again demanded that the amendment go forward to the Delegate body for a vote, per AKC's rules. Again, there were not two-thirds voting in the affirmative, so the second amendment to Chapter 11, Section 8-A failed.

March 2019 Meeting

The March meeting of the AKC Delegates was held on March 12, 2019, in Newark, New Jersey. There were 353 delegates in attendance.

In his report, President Sprung noted that 2018 ended in positive territory throughout the organization: Litters increased by 5 percent and individual dogs by 4 percent. The number of unique breeders grew by 6 percent. Aggregate entries were up more than 100,000, ending the year at 3,243,265 – the highest ever in AKC's history. Public relations and social media numbers were each positive. AKC.org had more than 8 million unique users monthly, plus increases in AKC Marketplace and Instagram with a recent gain of 10,000. The AKC Facebook page had almost 4 million followers. The AKC launched a major initiative, AKC.tv, under the direction of Gina, which is available on Apple TV, Roku, Amazon Fire, and through a mobile application.

On September 17, 2018, the date of our founding, we moved into our new office while simultaneously building the AKC Museum of the Dog and renovating our North Carolina operations facility. The year 2019 started off successfully as a dream come true for AKC and dog people with the opening of your Museum of the Dog.

Next, Joe Baffuto presented the Financial Report. For 2018, the AKC recorded 76.8 million in total revenue and 72.6 million in total expenses for an operating income of just over \$4.2 million, in comparison to the full audited 2017 year where we reflected 71.7 million in revenue with 65.6 million in operating expenses and a full year of 6.1 million in operating income. The AKC ended the 2018 year with \$162.7 million in total assets. Total liabilities increased fairly significantly from 73 million at the end of 2017 to 110 at December 31, 2018. Litter volume increased by 5 percent with a total annual volume of 251,000 in 2018. Dog registrations also rose by 4 percent for the year reaching 581,000. This marked five years of consecutive gains.

The sole vote of the meeting was on the Charter and Bylaws of The American Kennel Club, Article VIII, Section 1, which would require that the Board in its appointment of the 5-member nominating committee include three Delegates that have each been selected by a Delegate Committee in accordance with the proposed new standing rule. The Board would be permitted to appoint only two of the five members. The amendment was proposed by the English Springer Spaniel Field Trial Club of Illinois and unanimously disapproved by the AKC Board of Directors.

The English Springer Spaniel Field Trial Club of Illinois demanded that this amendment go forward to the Delegates for a vote as per the AKC Bylaws. There were not two-thirds voting in the affirmative, so the amendment failed.

The delegates voted to elect Dr. Charles Garvin, Daniel Smith, and Steven Hamblin to the Board of Directors, Class of 2023.

June 2019

The June meeting of the AKC Delegates was held on June 11, 2019, in Newark, New Jersey. There were 258 delegates in attendance.

Brandi Hunter, Vice President of Public Relations and Communications, shared information on the ways the AKC increased its messaging and audience, and on the AKC's value in the media space. Melissa Olund, Director of Digital Marketing, spoke about the three key goals of the AKC Marketing Department: 1) increase ownership and registration of purebred dogs; 2) increase awareness and participation in AKC sports and events: 3) improve dog lovers' perception of the AKC.

Next, Joe Baffuto, AKC Chief Financial Officer, gave a quarterly report on the AKC's finances and registration figures. Finances continue you on positive track. Both litter and individuals registrations continue to increase. The delegates voted on four rule and procedure changes.

The delegates voted on six amendments. The first vote was on the amendment to Chapter 11, Section 4 - Dog Show Entries, Conditions of Dog Affecting Eligibility, which would only change the format of the section. The amendment was proposed by the Delegate Dog Show Rules Committee and brought forward with approval from the AKC Board of Directors. The question is on Rules Applying to Dog Shows Chapter 11, Section 4. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 11, Section 4 now reads:

SECTION 4. To be acceptable, an entry must:

- Be submitted with required entry fee
 - Be on an Official American Kennel Club entry form
 Be signed by the owner or his duly authorized agent
 - Include the name and date of the show giving club
 - Include all of the following information on the dog
 - Breed
 - · Variety, if any
 - Sex
 - Name of class or classes entered (Classes must be entered in accordance with Chapter 3)
 - Full/Registered Name of Dog
 - · Date of Birth

- · Place of Birth
- Name of Sire
- · Name of Dam
- · One of the following:
 - AKC registration number
 - Or PAL number
- Or foreign registration number and country for an unregistered imported dog
 - Or identification number issued by AKC
- Name of Breeder(s)
- Name of Owner(s)/co-owner(s)
- · Name of Owner(s) agent, if any
- Address of Owner

No entry may be accepted unless the Superintendent or Show Secretary, named in the premium list to receive entries, receives such entry:

- · prior to the closing date and hour as published in the premium list
- · and in the case of a limited entry, prior to the time the limit is reached.

All the requirements of the foregoing paragraph and all other specific requirements printed in the premium list must be met before an entry can be considered acceptable. Failure to meet these requirements may result in the loss of all awards earned at the event.

The second vote was on the amendment to Rules Applying to Dog Shows Chapter 11, Section 12 - Dog Show Entries, Conditions of Dog Affecting Eligibility. The amendment changes an italicized portion of the section to be part of the rule. The amendment was proposed by the Delegate Dog Show Rules Committee and brought forward with approval from the AKC Board of Directors. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 11, Section 12 now reads:

SECTION 12. Any person acting in the capacity of Superintendent (or Show Secretary where there is no Superintendent), at a show, or any person residing in the same household with the Superintendent or Show Secretary shall not exhibit, act as agent or handler at the show, and dogs owned wholly or in part by him or by any person residing in the same household with him shall be ineligible to be entered at that show. The official veterinarian shall not exhibit, act as agent or handler at the show, and the dogs owned wholly or in part by him shall not be eligible to be entered at that show.

A Superintendent, an individual licensed to superintend events as an employee of the Superintendent, any other employee of the Superintendent, or any person residing in the

same household as any of the foregoing, shall not exhibit or act as agent or handler, at any show held thirty days before or after a show which the Superintendent has been approved to service by The American Kennel Club.

Dogs owned wholly or in part by a Superintendent, an individual licensed to superintend events as an employee of the Superintendent, any other employee of the Superintendent, or any person residing in the same household as any of the foregoing, shall be ineligible to be entered at any show held thirty days before or after a show which the Superintendent has been approved to service by The American Kennel Club.

For the purpose of this section, the employees of a Superintendent would include only those individuals who represent the Superintendent or superintending organization at dog shows.

The third vote was on the amendment to Rules Applying to Dog Shows Chapter 11, Section 13 - Dog Show Entries, Conditions of Dog Affecting Eligibility, which changes the section to be gender neutral, changes the first two paragraphs of italics to become part of the rule and adds clarification. The amendment was proposed by the Delegate Dog Show Rules Committee and brought forward with approval from the AKC Board of Directors. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 11, Section 13 now reads:

SECTION 13. No judge or any person residing in the same household with a judge shall exhibit or act as agent or handler at a show at which he/she is officiating as judge and dogs owned wholly or in part by such judge or any member of his/her household shall be ineligible to be entered at such show. Subject to the foregoing, members of a judge's immediate family as defined in this section who no longer reside in the same household may enter or handle a dog at a show if the judge is not officiating over any competition, including a group class or Best in Show, for which the dog is entered or may become eligible.

No entry shall be made at any show under a judge of any dog which said judge or any member of his/her immediate household or immediate family has been known to have owned, handled in the ring more than twice, sold, held under lease or boarded within one year prior to the date of the show.

For the purposes of this section, the members of an immediate family are one's spouse, domestic partner, parents, grandparents, children, grandchildren, siblings, mother-in-law, father-in-law, brothers-in-law, sistersin-law, daughters-in-law, and sons-in-law; adopted, half, and step members are also included in immediate family.

The above will apply to judges of sweepstakes or futurities held with licensed or member shows exactly as it does to judges of regular competition at shows.

This provision prohibiting judges or those residing in the same household from exhibiting on the same day does not apply to the judge of the Four-to-Six Month Competition or to Junior Showmanship only judges. Such judges may also exhibit on the day(s) they judge.

The third vote was on the amendment to Rules Applying to Dog Shows Chapter 14, Section 8 - Measuring, Weighing and Color Determinations When Factors of Disqualification in Breed Standards or Eligibility Under Conditions of a Class or Division of a Class Cancellations of Awards, which rewords the section only. The amendment was proposed by the Delegate Dog Show Rules Committee and brought forward with approval from the AKC Board of Directors.

There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 14, Section 8 now reads:

SECTION 8. At the request of the owner or handler of an exhibit, any errors in the catalog and/or judge's book at any show, which are contrary to the information appearing on the entry form of that dog for that show, shall be corrected in the judge's book by the Show Secretary or the Superintendent prior to the judging and in the marked catalog to be sent to The American Kennel Club. Said dog may compete in all classes and for all prizes for which it was properly entered on the entry form.

The last vote was on the amendment to the Rules Applying to Dog Shows Chapter 16, Section 6 - Championships, which changes the italicized portion of the section to be part of the rule. The amendment was proposed by the Delegate Dog Show Rules Committee and brought forward with approval from the AKC Board of Directors. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 16, Section 6 now reads:

SECTION 6. Champions of Record and dogs which have completed the requirements for a championship but whose championships are unconfirmed that are entered in Best of Breed competition are eligible for Grand Championship competition. Grand Championship points may be recorded for: Best of Breed or Best of Variety of Breed, Best of Opposite Sex to Best of Breed or Best of Variety of Breed, Select Dog, and Select Bitch.

Grand Championship points will be recorded according to the number of eligible dogs competing in the regular and non-regular (eligible for Best of Breed/ Variety) classes of each breed or variety, as well as dogs competing in Best of Breed competition, according to the Schedule of Points established by the Board of Directors.

- Grand Championship Points will not be awarded for competition beyond Best of Breed or Best of Variety of Breed competition.
- Winners Dog, Winners Bitch, and Non-Regular Class winners that are not conformation Champions, are not eligible for Grand Championship points.

Grand Championship points for a dog awarded Best of Breed or Best of Variety of Breed shall count all eligible dogs of both sexes entered in Best of Breed or Best of Variety of Breed competition in addition to the dogs that competed in the regular and non-regular (eligible for Best of Breed/Variety) classes for both sexes in calculating Grand Championship points.

Grand Championship points for a dog awarded Best of Opposite Sex to Best of Breed or Best of Variety of Breed shall count all eligible dogs of their sex competing in Best of Breed or Best of Variety of Breed competition in addition to the dogs that competed in the regular and non-regular (eligible for Best of Breed/Variety) classes for their sex in calculating Grand Championship points.

A dog awarded Best of Breed will be credited with the number of Grand Champion points calculated for Best of Breed or for the Best of Opposite Sex, whichever is greater.

Grand Championship points for a dog awarded Select Dog or Select Bitch shall count all eligible dogs of their sex in Best of Breed or Best of Variety of Breed competition less the dog awarded Best of Breed or Variety or Best of Opposite Sex to Best of Breed or Variety in addition to the dogs that competed in the regular and non-regular (eligible for Best of Breed/ Variety) classes for their sex in calculating Grand Championship points.

September 2019

The September meeting of the AKC Delegates was held on September 10, 2019, in Newark, New Jersey. The official number of delegates in attendance has not been released as of yet.

The delegates voted on candidates for the Delegate Standing Committees.

The Forum topic was "AKC Purposefully Bred Pure-Bred Dogs and the Preservationist Breeders who Bring Them into the World. Who Are We? Where Are We Headed? How Can AKC Assist in Our Success?" The presenters were Bill Shelton of Coventry Pembroke Welsh Corgis and AKC Herding Group Breeder of the Year 2017 and Doug Johnson of Clussexx — Clumber, Sussex, Welsh Springer & English Toy Spaniels and AKC Sporting Group Breeder of the Year 2005.

After the Presidents report, Cody Barr, Social Media Manager, gave a presentation on maximizing Facebook efforts.

Next, Joe Baffuto, AKC Chief Financial Officer, gave a quarterly report on the AKC's finances and registration figures. Operating income is well ahead of 2018 figures. Total expenses through July 31, 2019, have decreased by \$765,000 or 1.8% from July 31, 2018. The AKC's payroll and benefits costs have decreased by about 1%, \$112,000, despite a coinciding head count increase year-over-year of 357 full time equivalents in comparison to 345. All sports and events income has risen by 8.5% or \$771,000 as compared to the seven months ended July 2018. Our relative benchmark for our portfolio during the comparative period was 11.15%, so we're currently outperforming the expectations set for our portfolio so far this year by 120 basis points. The non-consolidated balance sheet of the AKC dated July 31, 2019, reflects \$174.1 million in total assets. The AKC's cash and investment balances total more than 65% of these assets with almost another 15% in related party receivables. This is the core financial strength for the AKC. The AKC's total liabilities recorded are \$104.7 million. Almost 60% of the AKC's liabilities lie within our long term pension or post-retirement obligations. The AKC's relative benchmark for its portfolio during the comparative period was 11.15%, outperforming the expectations set for the AKC's portfolio so far this year by 120 basis points. The nonconsolidated balance sheet of the AKC dated July 31, 2019, reflects \$174.1 million in total Total liabilities recorded are \$104.7 million. Year-to-date, the AKC has registered approximately 152,000 litters, which is a 2.7% increase from 2018, as well as 357,500 dogs, which represents a 1.8% prior year increase.

The delegates voted on three rule and procedure changes. The first vote was on an amendment to the Rules Applying to Dog Shows, Chapter 7, Section 12, Judges, which allows clubs to officially close out a ring on the day. This amendment was proposed by the AKC Board of Directors, endorsed by the Delegates Dog Show Rules Committee and brought forward by the AKC Board. There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 7, Section 12 now reads:

SECTION 12. Any club or association that holds a dog show must prepare, after the entries have closed and not before, a judging program showing the time scheduled for the judging of each breed and each variety for which entries have been accepted. If a substitute or additional judge has been approved Chapter 7, Section 8 or Chapter 7, Section 13, as appropriate, will be quoted listing the changes. The judging program shall indicate the number of dogs entered and state the time for the start of group judging, if any. The program shall be based on the judging of about 25 dogs per hour by each judge. Each judge's breed and variety assignments shall be divided into periods of about one hour, except in those cases where the entry in a breed or variety exceeds 30. The final

segment of a ring schedule may be expanded but may not exceed 50 dogs unless the entry is in a single breed or variety. The total number of dogs assigned each judge will be indicated.

Printed documents may be utilized at the exhibitor's request.

The judging program shall be published in the catalog. No judging shall occur at any show prior to the time specified in the judging program.

The first vote was on an amendment to the Rules Applying to Dog Shows, Chapter 14, Section 2 - Measuring, Weighing and Color Determinations When Factors of Disqualification in Breed Standards or Eligibility Under Conditions of a Class or Division of a Class Cancellations of Awards, which would reword the section to incorporate broader language regarding the display of identification by a person or dog exhibiting. This amendment was proposed by the Delegate Dog Show Rules Committee and brought forward with approval from the AKC Board. I spoke against this amendment. The following is a transcript of my comments.

The Chair recognized John Robert Lewis, Delegate for Sussex Spaniel Club of America, who spoke as follows:

Mr. Lewis: I don't have an amendment, but I do have two point-of-information inquiries now. I'm Bobby Lewis, I'm with the Sussex Spaniel Kennel Club of America. My inquiry is about the last sentence of the proposed amendment to Section 2. My first inquiry is: would the Professional Handler Association be considered a "local, national or charitable organization" and secondly, would passage of the amendment that's written now permit a professional handler to wear a Professional Handler Association lapel pin in the confirmation ring?

Mr. Sprung: The Handlers Associations will be national in scope. Yes, they may wear a pin.

Mr. Lewis: The second and third sentence of the amendment appears to prevent an exhibitor from gaining an advantage in the show ring by requiring the person not reveal the identity of himself or herself or the identity of the dog, the kennel or the handler. To me, it is problematic to adopt a rule that includes language that would allow a practice that gives rise to the appearance of impropriety by allowing an exhibitor to identify himself or herself as a professional handler. Thank you.

Mr. Sprung: That's also applicable to Owner Handlers Associations.

After a vote count, 165 delegates voted in favor of the amendment, and 121 voted against. Since there was not a two-thirds majority, the amendment failed.

The third and final vote of the September meeting was on the amendment to Rules Applying to Dog Shows, Chapter 14, Section 9 - Measuring, Weighing and Color Determinations When Factors of Disqualification in Breed Standards or Eligibility Under Conditions of a Class or Division of a Class Cancellations of Awards, which permits move-ups to occur when an award has been disallowed in non-regular classes and also in groups; it further reiterates that this will occur when Best in Show is canceled. The amendment was proposed by the Delegate Dog Show Committee and brought forward with approval from AKC's Board.

There were two-thirds of the delegates voting in the affirmative and the amendment passed. Chapter 7, Section 12 now reads:

SECTION 9. If an award in any class is canceled, including non-regular classes, groups and Best in Show, the dog(s) judged next in order of merit in all placements of that class shall be moved up. The award(s) to the dog(s) moved up shall be counted the same as if it had been the original award. If there is no dog of record to move up, the award shall be void.

AMERICAN KENNEL CLUB ANNOUNCES EXPANSION OF THE AKC S.A.F.E. GROOMING PROGRAM

New York, NY –The American Kennel Club (AKC ®) is pleased to announce the expansion of its AKC S.A.F.E. Grooming Certification Program with a "Safety in the Salon Recertification Course." The course was soft-launched at Groom Expo, hosted by Barkleigh Productions, Sept. 12-15th in Hershey, PA.

"The launch of the Safety in the Salon Recertification Course brings the AKC S.A.F.E. Grooming Certification Program full circle," stated AKC Executive Vice President Mark Dunn. "The American Kennel Club recognizes that the health and safety of pets when outside of their owner's care remains a genuine concern for pet owners, and recertification gives grooming professionals an opportunity to stay current on groom safety best practices, while also giving their clients the peace of mind they deserve."

In 2015, the American Kennel Club introduced its "AKC Safety in the Salon" course, which was created to enhance trained grooming professionals' knowledge of the salon safety practices to help keep themselves and all pets safe while in their care. Now taught at grooming and pet expos nationwide and available online through AKC's Canine College, this comprehensive class provides vital information on safety measures and protocols within the grooming facility, including accident avoidance, pet and

zoonotic diseases, sanitation and how to handle special cases. To date, more than 3,000 grooming professionals have successfully completed the course.

After their initial program certification period, AKC S.A.F.E. Certified Groomers and Salons will be required to recertify online via AKC's Canine College. In order to maintain their certification status, AKC S.A.F.E. Certified Salons must recertify annually. AKC S.A.F.E. Certified Groomers need to recertify every two years.

The recertification course provides grooming professionals with a comprehensive review of the AKC S.A.F.E. Certified Groomer/Salon Oath and its requirements, plus new strategies on how to keep themselves and pets safe in the grooming facility while in their care. Both AKC S.A.F.E Groomers and Salons must demonstrate their grooming experience and pledge to safety. S.A.F.E. Salons must also agree to onsite inspections by AKC in order to maintain S.A.F.E. Certification status. S.A.F.E. Certified Groomers and Salons will then receive a certificate to display in their business.

All AKC S.A.F.E. Certified Groomers and Salons are given the opportunity to list on AKC Marketplace (<u>marketplace.akc.org</u>) upon certification. Dog owners can search this growing platform to find AKC S.A.F.E. Certified Groomers and Salons in their area.

According to the American Pet Products Association, \$6.11 billion was spent on pet care services such as boarding and grooming services in 2018, a figure that is projected to increase to \$6.31 billion in 2019.

Licensing for pet groomers has also gained attention since "Bijou's Law" was introduced in New Jersey, which would require all pet groomers and salons to be licensed by the state.

"As the number of proposals at the state and local level to regulate professional groomers and grooming salons increase, the AKC will continue to support training and oversight for professional groomers to ensure that health and safety is always a primary consideration when grooming a dog," stated AKC Vice President of Government Relations Sheila Goffe. "We recommend that grooming professionals pass a course and exam on basic health and safety standards, such as AKC S.A.F.E. Grooming."
